CIRCULAR LETTER N°.(6) RSS/MT&I/J/18/12/2020 TO INFORM ON THE PARTNERSHIP BETWEEN THE SOUTH SUDAN GOVERNMENT & K-POLYGONE SAS

The present circular letter is to inform that Government has launched the implementation of the Electronic Cargo Tracking Certifications). All the transporters (Shipping companies, Airlines Cargo, Road Transporters, Forwarders Agent and Others involved into the transport of goods with destination or origin of the Republic of South Sudan.

In consideration of the ministerial order allowing the administration of the Republic of South Sudan to meet international standards of safety and trade facilitation, the South Sudan authorize K-POLYGONE, who accepts, to become its Representative on worldwide basis (Europe, Americas, Africa, Middle East and Asia) towards publics or private companies for the specific and limited scope to enhance security and facilitating custom clearing processes of goods, by anticipating effective validated data information, regarding the import/export and transit of goods shipped in containers or bulk by the road, air and maritime transport, between the Republic of South Soudan and the rest of the World

FOR THIS PURPOSE:

Article 1:

All Transporters companies, shippers and freight forwarders Road carriers, Importers and Shipping Lines, Airlines and Others involved into the transport either for goods import / export or in transit from and to the Republic of South Sudan will have to comply with all requirement of the trade Facilitation system implemented by the Republic of South Soudan. Article 2:

We inform all transportation companies of the following compulsory regulations to be applied, all the required documents and the confirmations related to the issuance must be validated by the Technical Partner. It must declare the following data:

- Freight Forwarder: Name / Address / Tel / Fax, Email
- Importer/Exporter: name / address / Tel / Fax, Email
- Complete planned routing from POL to POD with indication of all transshipments, scheduled vessels, voyage number, ETA; ISO code of the goods, Origin of the goods; IMO class if applicable.
- Incoterm: Goods Values, basic freight and surcharges, insurance, Freight settlement (Prepaid or Collect).
- Scanned copy of the Bill of lading

- Scanned copy of the commercial invoice
- Scanned copy manifest of the shipment a detailed description of the cargo. (Type of package and parcel number; Volume / net weight / gross weight)

Article 3: Tariffs

The Government reminds that all the cargo bound to Republic of South Sudan must be covered by the ECTN certificate compliance with the procedure at loading ports overseas, for the discharge in the Republic of South Soudan.
