Subject: MINISTERIAL ORDER NO. 24/2022 FOR LIFTING SUSPENSION OF K-POLYGONE SAS:

1. The title and Commencement;

This Ministerial Order shall be cited as Ministerial Order NO 24 /2022 AD for lifting the Suspension of K-Polygone SAS by the National Ministry of Trade and Industry shall come into force on the date of its signature

2. Purpose;

The Purpose is to inform the stakeholders that the parties had ratified the issue that caused the suspension of the implementation of the contract. Therefore, this order shall be cited as a lift of suspension of K-Polygone SAS and allowed the party to resume the implementation of the Contract.

3. The Order;

In an exercise of the powers conferred upon me under Article 114 (1) of Transitional Constitution of the Republic of South Sudan, 2011, read together with Article 17 and 18 of Imports and Export Act, 2012, I, **Hon. Kuol Athian Mawien**, Minister of Trade and Industry, Republic of South Sudan, do hereby issue this Ministerial Order No 24/2022 as follow;

- i. This is a lift of suspension with immediate effect for the implementation of the contract carry on by K-Polygone SAS and its partners from ALL ports to entry Port of Nimule, South Sudan.
- ii. The **K-Polygone SAS** is inimical to the general undertaking by stakeholders to “abstain from any measures likely to jeopardize the implementation of the provisions of the Contract without a clear consent of the contracting authority as it is in the roadmap.
- iii. The parties to the contract shall follow the right procedures and keep on addressing any issue that may jeopardize the successful implantation of the task in the Roadmap.
