# REF: MINISTERIAL ORDER NO. 20 FOR SUSPENDING THE OPERATIONALIZATION OF THE CONTRACT AGREEMENT BETWEEN THE NATIONAL MINISTRY OF TRADE AND INDUSTRY AND K - POLYGONE SAS:

## 1. The title and Commencement;

This Ministerial Order shall be cited as Ministerial Order No. 20/2021 AD for suspending the operationalization of the contract agreement between the National Ministry of Trade and Industry and K – Polygone SAS and shall come into force on the date of its signature

### 2. Purpose;

The Contract between the National Ministry of Trade and Industry and K – Polygone SAS has cause a lot of confusion, obstacles and interruption on transit goods coming to South Sudan

### 3. The Order;

In an exercise of the powers conferred upon me under Article 114 (1) of Transitional Constitution of the Republic of South Sudan, 2011, read together with Article 17 and 18 of Imports and Export Act,2012, I Hon. Kuol Athian Mawein, Minister of Trade and Industry, Republic of South Sudan, do hereby issue this Ministerial Order No.20/2021 as follow;

- i. This is to suspend with immediate effect the implementation of the contract on electronic cargo tracking certification carry on by K Polygone and its partners from Malaba port to entry port of Nimule, South Sudan without preconditions to the traders. This is because, it come to my attention that this contract and it annexes are being use to interrupt the cargo transiting to the Republic of South Sudan.
- ii. I am issuing this Ministerial Order to suspend all the exercise being undertaken by K-Polygone and its partners to avoid interruption on the transit goods coming to South Sudan.
